This Amendment No. 1 (this "Amendment") to the Schedule 13G (this "Schedule 13G") relates to shares of Common Stock, par value \$0.0001 ("Common Stock"), of KemPharm, Inc., a Delaware corporation (the "Issuer"), and is being filed on behalf of (i) Delaware Street Capital Master Fund, L.P.
